All collectively bargained employees for whom a contributing employer is required to make contributions and any non-collectively bargained employees for whom a contributing employer is required to make contributions or agrees to make contributions are eligible to participate under the Plan.

The Internal Revenue Service has previously issued a determination letter with respect to the qualification of this Plan.

### **RIGHTS OF INTERESTED PARTIES**

You have the right to submit to EP Determinations, at the above address, either individually or jointly with other interested parties, your comments as to whether this Plan meets the qualification requirements of the Internal Revenue Code.

You may instead, individually or jointly with other interested parties, request the Department of Labor to submit, on your behalf, comments to EP Determinations regarding qualification of the Plan. If the Department of Labor declines to comment on all or some of the matters you raise, you may, individually, or jointly if your request was made to the Department of Labor jointly, submit your comments on these matters directly to EP Determinations.

### **REQUESTS FOR COMMENTS BY THE DEPARTMENT OF LABOR**

The Department of Labor may not comment on behalf of interested parties unless requested to do so by the lesser of 10 employees or 10 percent of the employees who qualify as interested parties. The number of persons needed for the Department of Labor to comment with respect to this Plan is 10 employees. If you request the Department of Labor to comment, your request must be in writing and must specify the matters upon which comments are requested, and must also include: (1) the information contained in items 1 through 4 of this Notice; and (2) the number of persons needed for the Department of Labor to comment.

## **COMMENTS TO THE INTERNAL REVENUE SERVICE**

Comments submitted by you to the Internal Revenue Service must be in writing and received by March 15, 2010. However, if there are matters that you request the Department of Labor to comment upon on your behalf, and the Department of Labor declines, you may submit comments on these matters to the Key District Director to be received within 15 days from the time the Department of Labor notifies you that it will not comment on a particular matter, or by March 15, 2010 whichever is later, but not after March 30, 2010. A request to the Department of Labor to comment on your behalf must be received by it by February 13, 2010, if you wish to preserve your right to comment on a matter upon which the Department of Labor declines to comment, or by February 23, 2010 if you wish to waive that right.

Detailed instructions regarding the requirements for notification of interested parties may be found in Sections 17 and 18 of Rev. Proc. 2010-6. Additional information concerning this application (including, where applicable, an updated copy of the Plan and related trust; the application for determination; any additional documents dealing with the application that have been submitted to the Service; and copies of Sections 17 and 18 of Rev. Proc. 2010-6) are available at the offices of the Plan Administrator during normal business hours for inspections and copying. (There is a nominal charge for copying and/or mailing.)
